1. BRIEF

Mahatma Phule Renewable Energy and Infrastructure Technology Limited (MAHAPREIT) is wholly subsidiary of MPBCDC, a Govt of Maharashtra company, engaged in Renewable Energy and Infrastructure Technology. Mahapreit has separate verticals of Emerging Technology areas, Infrastructure, Affordable housing and Renewable Energy-E Mobility (EV). Mahapreit identifying new initiatives and new project proposals primarily to support startups entrepreneurs and individual / other entity beneficiaries as eligible under MPBCDC norms, as notified from time to time. The projects are also intended to create employment and revenue generations for the target community group.

MAHAPREIT desires to appoint various Channel Partners for carrying out specified projects to achieve the above objectives in various verticals. The scheme of Channel partners will also make variable good opportunity to newer technologies to industry and stake holders of such projects. Each vertical will be allocated different categories of Channel Partners so as to develop the projects on fast track and to support the qualified stake holders as per eligibility norms of various projects / bid process as may be undertaken or participated or managed by MAHAPREIT.

2. CHANNEL PARTNERS: CATEGORIES

(1) **Knowledge Partners** (KP) — May be individual or legally registered entity or Institutes of Eminence in India or abroad.

- c. Institutes of eminence/ Universities having appropriate ranking in India as per GoI approved rating mechanism / Foreign universities having world rank within top 100 / IITs/IIMs/NITs
- d. Laboratories in India as well abroad / testing centres / Research institutes / Validating facilities for various research works in relation to Mahapreit activities.
- (2) Capex Partners (CP) May be Public or Private investment companies/FI/Banks / Funds or Foundations under not-for-profit category or otherwise / Corporate Social Responsibility funds / any other companies or entities registered in India under relevant act.

- b. Digital currency / Block chain
- c. Foundations and Endowment funds, CSR
- d. FI/ External FI/ Banks/ Development banks
- (3) Target Partners (TP) (Navyug Beneficiaries) Scheduled Caste / backward class individuals/ Agencies / entities eligible to get benefits of any scheme under Department of social justice and empowerment, GOI and /or GOM AND befitting under beneficiary category mandate or beneficiary eligibility norms of MPBCDC as decided by GOM from time to time.

- c. SHG/ Women groups

4. REGISTRATION AND APPLICATION

- a) Interested parties / entities / individuals shall register with MAHAPREIT through Google form available with advertisement (Annex 1) https://forms.gle/myhSjsjqkE6qjM1J7.
- b) Application Fee Rs 5000/ as prescribed in EOI to be paid by DD/RTGS/or Other digital payment method. Any state/central govt. departments or its agencies or CPSU/SPSU/Govt banks /IIT/IIM/NIT or any institute/organisation or company established by act of parliament or state legislature are exempted from application fee. No application fee is required for Target Partner Category.
- c) Basic documents to be submitted Only with self-certification
- d) Application time one month.
- e) Maximum no. of application Any individual / party / entity for KP and CP class/ categories will be allowed to apply only in TWO Type, out of 1,2 and 3 types of Interest Areas as mentioned at Para No (3) above. To be more clear, only TWO application can be made from ETAP and/or Renewable Energy and/or Affordable housing. However, 2 separate applications can be made for maximum 2 (two) sub types in any type from type 1,2,3 by one applicant. It is further provided that any individual / party / entity for KP and CP class/ categories the respective applicant can make application additionally on any 4 ETA which may or may not include max 2 sub Emerging technology area (ETA) from Type 4, Sr. No 6, (HDV areas) as mentioned at Sr. No 3 (IV) from Type 4. However acceptance and Approval process will be done based on eligibility and norms as decided by company vide separate notification.
- f) For TP category, any applicant / legal entity will be allowed to apply to work or engaged himself/ herself/ their self in max 2 types out of 4 types of ETA as mentioned above at Para 3 and also the TP applicant shall have to select only one sub ETA out of all ETA mentioned in any 2 types of their/his/her choice for start-up or engagement or self-employment or employment as the case may be.
- g) For treating conflict of interest for deciding whether any applicant has applied in more than 1 (one) type, Standard bidding practices and /or rules notified by NITI Aayog or any competent authority in that behalf will be applicable. Also, any applicant will be allowed to apply in any one category of Channel partner as mentioned at para (2).

- i) The no. of empanelled channel partners will be notified from time to time in each type as per need of Mahapreit after primary selection. However, select list will be freezed for the prescribed time period.

5. EMPANELMENT

- 1) Based on Select list in each category and Type, Channel partners will be Empanelled.
- 2) Tenure: 2 years from the date of empanelment however MAHAPREIT reserve the right of tenure extension if anv.
- 3) Empanelment will be considered for only One subtypes based on eligibility and requirement of Mahapreit. However, Mahapreit keeps it right reserved to consider more than one subcategory for any applicant if otherwise found eligible.
